Spring will soon be here! And with spring, come the rains. As much as we appreciate the rain here in California and elsewhere in the USA, our friends down at the HEI Home in Tlaxiaco do NOT appreciate the rains. Why? Because their roof was not properly sealed, and torrential rains came in last year and have damaged many walls. This is a serious matter, as mold is growing and students breathing it in can get seriously ill.

We need to help them out. It has been estimated that \$4000 is needed to repair and seal the roof, and to repair the plastered walls upstairs and down, as well as damage to the outside walls.

We not only have to send funds monthly for living expenses for the students and children in our Homes—we also need to find money to make needed repairs to this and several other Homes.

A trip to Mexico every year is on her calendar, so she can make sure that the children and students are well cared for, as well as taught to love God.

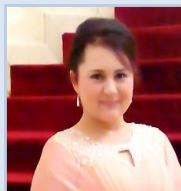
A Note of Thanks From One of the Girls in our MANO Home
